#### ANNOUNCEMENT AND NOTICE OF TERMINATION, VOLUNTARY DEAUTHORISATION AND DELISTING

The termination of the KOSPI 200 ETF and the deauthorisation of the KOSPI 200 ETF became effective on 22 February 2018. The delisting of the KOSPI 200 ETF from the SEHK also became effective from 9:00 a.m. on 22 February 2018.

Reference is made to the Announcement and Notice dated 20 November 2017 and entitled “Announcement and Notice of the Proposed Cessation of Trading, Termination, Voluntary Deauthorisation and Delisting and Waiver from Strict Compliance of Certain Provisions of the Code” (“**First Announcement**”) and the Announcement dated 18 January 2018 and entitled “Final Distribution Announcement”, both issued by Mirae Asset Global Investments (Hong Kong) Limited (“**Manager**”), the manager of the Trust and the KOSPI 200 ETF. Capitalised terms not defined in this Announcement shall have the same meanings as defined in the First Announcement.

The purpose of this Announcement and Notice is to inform the investors that the Trustee and the Manager have formed an opinion on 22 February 2018 that the KOSPI 200 ETF has no outstanding contingent or actual liabilities or assets. The termination process of the KOSPI 200 ETF has also been completed.

Furthermore, the SFC has approved the deauthorisation of the KOSPI 200 ETF (“**Deauthorisation**”) and the SEHK has approved the delisting of the KOSPI 200 ETF from the SEHK (“**Delisting**”). The Deauthorisation became effective on 22 February 2018 (“**Termination Date**”) and the Delisting also became effective from 9:00 a.m. on the Termination Date.
